### Privacy Policy

This Privacy Policy describes our policies and procedures regarding the collection, use and disclosure of your information when you use the Service and informs you of your privacy rights and how the law protects you.

We use your personal data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy. #### Interpretation and definitions

##### Interpretation

Words whose initial letter is capitalized have defined meanings under the following conditions. The following definitions have the same meaning regardless of whether they appear in the singular or plural.

##### Definitions

- For the purposes of this Privacy Policy:
- Account means a unique account created for the User to access our Service or parts of our Service (Not used by Third Parties).
- Application refers to VIRT7, the software program provided by the Company.
- Company (referred to as "the Company", "We", "Us" or "Our" in this Agreement) refers to VIRT7.
- Country refers to: Portugal
- Device means any device that can access the Service, such as a computer, cell phone or digital tablet.
- Personal data means any information relating to an identified or identifiable natural person.
- Service means the application.
- Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third party companies or individuals contracted by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform



services related to the Service or to help the Company analyze how the Service is used.

- Usage Data refers to automatically collected data, either generated by the use of the Service or by the Service infrastructure itself (for example, the duration of a page visit).

- You means the individual accessing or using the Service, or the company, or other legal entity on whose behalf that individual is accessing or using the Service, as applicable

#### Collection and use of your personal data

##### Types of data collected

##### Personal Data

When using our Service, we may ask you to provide us with certain personally identifiable information (which will not be shared with Third Parties) that can be used to contact or identify you. Personally identifiable information may include, but is not limited to:

- Email address
- Username (Not Required)
- Phone Number (Not Required)
- Address and Postal Code (Not Required)

##### Usage data

No data is collected about the App user's device.

When you access the Service via a mobile device, we may collect certain information automatically, unique device identifiers and other diagnostic data.

##### Information collected while using the App


- When you use our App to provide features of our App, we may collect, with your prior consent:
- Images and other information from your device's camera and photo library

We use this information to provide features of Our Service, to improve and personalize Our Service. The information may be uploaded to the Company's servers and/or to a Service Provider's server or may simply be stored on your device.

You can enable or disable access to this information at any time via your Device settings.

##### Use of your personal data

- The Company may use Personal Data for the following purposes:

- To provide and maintain our Service, including to monitor the use of our Service.
  - To manage your account: to manage your registration as a user of the Service. The Personal Data you provide may give you access to different features of the Service that are available to you as a registered user.
  - To contact you: To contact the User by email, or other equivalent forms of electronic communication, such as push notifications from a mobile application about updates or informative communications related to the functionalities, of the App including security updates, when necessary or reasonable for their implementation.
  - To manage your requests: To fulfill and manage your requests to us.

We may share your personal information in the following situations:

- We do not share Users' personal information with third parties without their consent. However, this data may be shared with competent authorities if necessary to comply with legal obligations.

Retention of your personal data

The Company will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable law), resolve disputes and enforce our legal agreements and policies.


The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen security or to improve the functionality of Our Service, or when We are legally obliged to retain this data for longer periods of time.

Transfer of your personal data

Your information, including Personal Data, is processed at the Company's operational offices and any other locations where the parties involved in the processing are located. This means that this information may be transferred to - and held on - computers located outside your state, province, country or other governmental jurisdiction where data protection laws may differ from those in your jurisdiction.

Your consent to this Privacy Policy, followed by your submission of such information, represents your agreement to such transfer.

The Company will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.



### Deleting your personal data

You have the right to delete or request our assistance in deleting the personal data we have collected about you.

Our Service may give you the ability to delete certain information about you from the Service.

You can update, change or delete your information at any time by logging into your account, if you have one, and visiting the account settings section that allows you to manage your personal information. You can also contact us to request access, correction or deletion of any personal information you have provided to us.

Please note, however, that we may need to retain certain information where we have a legal obligation or basis to do so.

### Disclosure of your personal data

#### Business transactions

If the Company is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will notify you before Personal Data is transferred and becomes subject to a different Privacy Policy.

#### Law enforcement

Under certain circumstances, the Company may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

#### Other legal requirements


The Company may disclose Your Personal Data in the good faith belief that such action is necessary to:

If We must rely on consent as the legal basis for processing Your information and Your country requires the consent of a parent, We may require the consent of Your parent before collecting and using that information.
